We partner with veterinarians and pet owners to provide supplemental financial resources.

FVHP fills a unique gap in funding not typically covered by animal welfare groups. FVHP funds treatments for curable (lifesaving, not life prolonging) diseases such as tumors, ambulatory care, broken bones, expensive medication, or postsurgical prosthetics like a K-9 cart. FVHP does not fund diagnostics or preventative measures like xray, ultrasound test or MRI.
